

DESCRIPTION

AC-25 is a highly effective acidic detergent system. It combines a variety of components which will quickly strip away acid soluble contaminants. Industrial and institutional applications for this formulation are extensive. Listed below is a partial list of some known product applications. Consult your Wechem Sales Consultant for application assistance. **AC-25** will not harm pipes or drains.

FOOD INDUSTRY - Stainless steel cleaning and brightening, demineralizing cooking and processing equipment, concrete, tile and grout cleaner, glass rinsing, demineralizing dishwashers and ice machines. Restores quarry tile to its original porous condition and increases slip resistance.

ANIMAL SHELTERS AND RESEARCH FACILITIES - Effectively removes calcium deposits and milk stains from equipment, tanks and lines. Effective in hard water areas. May be used with both hot and cold water.

INDUSTRIAL - Rust removal, scale and lime removal, concrete cleaning, coil cleaning, redi mix truck cleaning, aluminum, fiberglass and metal cleaning.

FLEET OPERATIONS - Metal and glass surface cleaner and brightener, hard water stain removal, pre-soak cleaner.

DIRECTIONS

Dilution ratio will vary depending on the method of application, the extent of the soil load, and the type of surface to be cleaned. Dilution should be adjusted by the user until optimal results are obtained. Apply diluted product and allow sufficient contact time for soil removal, do not allow product to dry on surface. Mechanical agitation will enhance chemical action. Rinse thoroughly with clean water to remove loosened soil and chemical residue. The following dilution table below may be used as a general guide.

General Dilution Table

USES	AC-25	WATER
Light Cleaning	1 part	40 to 80
Medium Cleaning	1 part	25 to 40
Heavy Cleaning	1 part	10 to 25
Extra Heavy Cleaning	1 part	3 to 10
