The special lifting action of this product will allow for easy rinsing and equipment cleaning. Formulated for use with oil separators.

DIRECTIONS:

BLUE MAX II is highly concentrated and should be diluted with water prior to use. The strength of cleaning solution required will vary according to the soil load and method of application. Use the suggested **General Dilution Table** as a starting point.

General Dilution Table

USES	BLUE MAX II	WATER
Light Cleaning	1 part	20 to 50
Medium Cleaning	1 part	10 to 20
Heavy Cleaning	1 part	5 to 10
Extra Heavy Cleaning	1part	2 to 5
