## DIRECTIONS FOR USE

Wet down surface with a hose to cool.

- For **heavy oxidized or soiled surfaces** - use straight solution.
- For **milder oxidized surfaces** - dilute solution 50/50 with water.

Start at the bottom and work upward. Cover a 5 to 10-foot section at a time. Allow to sit 3 to 6 minutes, brush if heavy soiled, then rinse from the top down.

For best results solution must be rinsed while still wet. If drying occurs reapply solution before rinsing. For heavily oxidized surfaces a second application may be necessary.
